Should you fail to pay the said date, your booking will automatically be cancelled, without any notice.

Terms & Conditions

1. AMENDMENT Of RULES

"The management" (refer to the owner of Arbeidsloon and the representatives). "The management" reserves the right to the terms and conditions for the use and utilization of Arbeidsloon Campsite to modify without prior notice.

2. RIGHT OF ADMISSION RESERVED

The management reserves the right to access and/or accommodation to any person or institution to refuse without disclosure of any reason. Management shall furthermore be entitled to order expulsion of any person who does not comply with the rules, noise, disturb the peace, a nuisance of him or herself:

- 2.1 Noncompliance of number of vehicles and number of persons: (Quantities per camp site). Four (4) persons per camp site, one (1) vehicle with one (1) Caravan/tent or 2 tents or one (1) "boswa" with single tent.
- 2.2 Failure to vacate a camp site after the reserved. Visitors must leave the camp clean and tidy place garbage in drum by farm supplied.
- 2.3 Failure to sign in as a visitor or access to camp place without payment.

3. GENERAL Rules

- 3.1 This campsite is located on a working farm with animals. Do not disturb the farm animals, wildlife and nature.
- 3.2 Water on the farm are not recommended as drinking water, bring your own drinking water. (E.g. 5 l Bottled water). Bottled water is available for sale at Kiosk/Reception.
- 3.3 Only one vehicle is allowed per campsite. Please keep the vehicle on the stand be awarded to you. (Permission for 2nd vehicle should be arranged with Management).
- 3.4 Speed limit for the camping area 20km/h and on all grounds outside 40 km/h.
- 3.5 Each camp site has one plug, one waterpoint and share a sink with stand next to.
- 3.6 **No pets are allowed.**
- 3.7 No smoking is allowed in ablution block and cigarettes may not be scattered around.
- 3.8 Don't leave any clothes and toiletries in ablutions.
- 3.9 No abuse of alcohol or other narcotic drugs.
- 3.10 No fires are allowed outside camp stands. Only in braai drums provided. The site is surrounded by fynbos and any sign of arson or irresponsible making fires is prohibited.

- 3.11 No day campers are allowed. Arrange with management for day visitor, the day visitor may not sleep over and must leave by 22h00 without disturbance and noise of vehicles.
- 3.12 **No music is allowed as well as TVs.**
- 3.13 We want our visitors to enjoy themselves, to respect fellow campers "SILENCE IN CAMP" from 22H00.
- 3.14 Children under the age of 10 years must be accompanied by an adult during the use of the ablution facilities. No foreign objects except toilet paper is allowed to be flushed down the toilets.
- 3.15 No empty bottles, containers or other garbage as well as cigarette butts may not be scattered. "Please put it in the garbage bins for this purpose.
- 3.16 Walkways used at own risk. Please stay within the instructions signage.
- 3.17 Crude language use such as swearing and abusive is not allowed.
- 3.18 Do not leave any alcohol for the workers and others.
- 3.19 "Quadbikes" or unlicensed vehicles are not allowed in the camp.
- 3.20 Bicycles are only allowed on dirt roads outside farm boundary and at own risk.
- 3.21 No use of firearms, bows and arrow, air rifles, ketties and fireworks.
- 3.22 Climbing over fences or gates are forbidden.

4. **RESERVATIONS AND RATES**

No booking will be valid and/or be enforceable unless:

- 4.1 The booking form is not completed and send to the management by email.
- 4.2 The required deposit payment as required, not received by the management and confirmed via e-mail.
- 4.3 Tariffs per camp site is R750.00 per night for 4 persons. a Maximum of 6 persons is allowed per camp site at an additional fee of R200.00 per person per night.
- 4.4 Group bookings (minimum 7 camp sites) at R_____ per 2 persons with a maximum of 6 persons per site. Extra R_____/night per person. If the group is less than 7 sites the normal rates will apply as in 4.3.
- 4.5 Weekend reservations a minimum of 2 nights (e.g. Friday and Saturday). If you want to stay over for longer, arrange and pay with Management.
- 4.6 Stand 7 has a permanent caravan for hire, rules for the hiring is available from Management.
- 4.7 There is a Kiosk on site at Reception where one can buy water, ice, cooldrinks, etc. and is open in the mornings and late afternoon in High Season 01 December to 15 January.
- 4.8 Make sure that your electrical appliances and leads are in good working condition before you start camping (no loose connections).

4.9 Contact management for more enquiries.

5. **PAYMENTS**

- 5.1 50% of the total cost of the stay is payable on receipt of booking as a deposit. The full payment (after payment of deposit) must be paid on 1 December in High Season or a week (7 calendar days) before arrival outside of Hight Season.
- 5.2 If booking is made within 7 days before arrival, the full amount is to be paid for the booked period.
- 5.3 Failure to pay the deposit, will lead the cancellation without prior notification.
- 5.4 Payment of extra persons can be made at arrival (R200.00 per person per night).
- 5.5 If the visitor must cancel due to death (or other acceptable reasons over which the person has no control), the deposit will be paid back. Only if supporting evidence can be provided.
- 5.6 No money will be refunded when guests leave the caravan park earlier.

6. **ARRIVAL AND DEPARTURE**

Arrival: 14h00

Departure: 12h00

If there are no arrivals after departure time, late departure can be arranged with management or earlier arrival.

7. **DISCLAIMER (as per Consumer Protection Act No 68 of 2008)**

Visit to the premises by any person and or their visitors, takes place on own risk and the owner and/or Manager and/or their representatives are indemnified against any claims of any nature what so ever caused, by way of either theft, death, injury, damage or loss of goods, fire, about may, floods and other natural disasters.
